

NGĀ MANA WHENUA O TĀMAKI MAKAURAU COLLECTIVE TREATY SETTLEMENT

Ratification of Deed of Settlement and Post-Settlement Governance Entities

The mandated negotiators for the 13 iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau have negotiated a collective redress offer from the Crown for the shared iwi/hapū interests in Tāmaki Makaurau. The offer is contained in the Tāmaki Makaurau Collective Deed of Settlement. The people of the iwi and hapū can now vote on whether to accept the proposed settlement and the post-settlement governance entities (PSGEs) that will administer the cultural and commercial settlement redress.

The two resolutions to be voted on are:

- 1. I support the Tāmaki Makaurau Collective Deed of Settlement.
- I agree that the Tūpuna Taonga o Tāmaki Makaurau [Cultural Redress] Trust and the Whenua Haumi Roroa o Tāmaki Makaurau [Right of First Refusal] Limited Partnership will be the post-settlement governance entities for the Tāmaki Makaurau collective settlement.

All registered adult members (aged 18 years or older) of each of the iwi/hapū are eligible to vote for each resolution using their voting method of choice: online via each iwi/hapū website (as shown above), by post, or in person by submitting their vote at information hui. Registered members who turn 18 years old during the voting period will also be eligible to vote.

If you are not yet a registered member, you can still vote. Contact the Returning Officer on free phone **0508 666 104** or **elections@electionz.com** for a special voting pack (including registration form). Alternatively, a special voting pack can be obtained at the information hui. Special votes, which are otherwise valid, will be counted subject to confirmation of registration.

Please ensure your registration details are up to date, and encourage your whanaunga to register if they have not already done so. People are also urged to contact their negotiators for information on iwi/hapū specific hui.

The voting period will commence on Monday, 2 July 2012 and will close at noon, Friday, 10 August 2012.
